### ED's Notes

- A Board decision needed on Incubation item 4b:
  - *Open Learning Analytics Processor has attracted no development effort for twelve months, and has been superceded in use by Apache Spark/Hadoop. The IWG is currently considering placing Open LAP in the "unsponsored contribution" category, as per our incubation process. It would be clearly labelled as such on the web site, with the meaning clearly explained.*
  - This code is suitable for use in querying data and may become the basis for other projects. The code would be reviewed regularly by the Incubation Working Group and if it has not been picked up in a year, we can review and decide to remove it from unsponsored projects. Note that this will be a new process for the IWG that the board can determine. Making this process more explicit will be a good task for the IWG review.

## **Executive Director's Written Report**

*Items not discussed in the Board meeting*

### **Conference planning.**

- (a) Has commenced with identification of key issues facing Higher Ed and education IT, based around recent EDUCAUSE documentation as grounding. Draft CfP is in development at <https://docs.google.com/document/d/1FY1Muxo97h9dL3bhiADPNWYUcAbJ6MSsHdm4SRvsh7I/> / Comment from the board is welcome. The CfP is timed for release in late November/early December. The Board strategic planning exercise can feed into the conference planning process.
- (b) Open Apero 2018 will be a "stop" on the OSI "World Tour" celebrating 20 years of the open source definition. OSI will fund a keynote (I have requested a speaker on women in open source), and further sponsorship.
- (c) The conference planning committee is exploring the potential for securing sponsorship for individual attendance for those who face financial obstacles - especially for those from the developing world. If any Board member has a source of funding (particularly a source that could otherwise not be unlocked), please contact me.

**Press releases** around the EQUELLA acquisition and LAMP MoU were well received on social media, and coincided with EDUCAUSE Conference. Australian HE comment was particularly interesting. I will attend LAK, the SoLAR Conference in Sydney in March 2018, and am working with our new commercial partner, Edalex, to maximise the impact and usefulness of the visit.

### **Incubation**

(a) Our new mentors, **Dede Hourican (Marist)**, **Lars Kiesow (U Osnabruck)**, and **Sam Lee Pan (U Cape Town)** have volunteered to mentor **EQUELLA, Notifications Backbone (Edinburgh) and Tsugi**, respectively. It should be noted that this represents the first engagement with the incubation process from members of the Sakai and Opencast communities. Negotiations with OSSWatch (U Oxford) to provide mentor training have begun. Susan Bramhall has retired as an incubation mentor. Further calls for mentors will be issued before the end of the year.

(b) We are proceeding to draw together incubating analytics projects, with the exception of Open Learning Analytics Processor, in order to develop appropriate governance further - in the first instance an advisory board. This will include Student Success Plan. The working name for this meta-project is Shuhari (see <https://en.wikipedia.org/wiki/Shuhari> and <https://www.martinfox.com/bliki/ShuHaRi.html> ). Thanks to Shoji-San for the suggestion. Our IP attorney has suggested that the registered marks in this name are different enough (mainly around catering) to make Trademark application straightforward.
